The list below details the services rendered as part of the 6 Lesson (Non-Boarder) package. This sheet is designed to provide clients with a clear overview and scope of the package and the accompanying services.

- Laurel Manor operates on a 4-week cycle and payments are due at the end of the first week in the training cycle (Sunday).
- Student receives 6 lessons (private, semi-private or group).
  - Private: 30 min.
  - Semi-private (2): 45 min.
  - Small group (3-4): 60 min.
  - Large group (5+): 75 min.
  - Individual private lesson(s) can be added to package (+\$40.00/lesson)
- Instructor determines size of lesson based upon rider's skill and scheduling limitations.
- Student or parent/guardian has signed a liability waiver.
- Student and parent/guardian have read and agree to follow the attached barn rules.
- Student and parent/guardian have read the Student Packet located on the website.
- Parent/guardian is responsible for coordinating, requesting, and communicating with instructor on scheduling (rider's 15 and younger).

This package includes the services mentioned above and is separate from other products, services, or programs students may participate in (IEA, showing, clinics, etc.)

# Laurel Manor Rules of the Barn

Although we strive to have fun at the barn, the rules outlined below are designed for the safety of the riders, guests, and spectators, as well as the horses and ponies. For this reason, these rules are strictly enforced and repeated failure to recognize and follow them will ultimately result in removal from the program and the property.

Minor riders require supervision at all times. Special circumstances require prior approval from Laurel Manor.

Riders are prohibited from mounting their horse inside the barn. Please use the designated mounting areas inside or adjacent to the arenas.

Always be mindful of your location with respect to any horses on the property. Be cautious not to startle the horses or ponies.

All equipment must be labeled and stored in its proper place. This includes items that have been left unattended (our barn is your barn too).

All students are required to clean up after themselves and their guests.

All riders utilizing a grooming area must pick up after their horse immediately after use and prior to riding. This includes manure, hoof pickings and hair.

The barn aisle and grooming stations must be kept free of tools, equipment, hair and manure.

Pets are prohibited from the barn area during lesson times. Permission is required outside of lesson hours.

No smoking is permitted at Laurel Manor.

Parents/guardians and guests are permitted to observe their riders during lessons at specified viewing locations. Please control small children and monitor them at all times.

Although horses are abundant on the property, horseplay to include running and screaming is prohibited.

*\*This list is not exhaustive and students will be instructed on additional rules around the barn during lessons.*
